**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is ROCK BOTTOM ENTERPRISES, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of ROCK BOTTOM ENTERPRISES, LLC, is P.O. Box 895374, Leesburg, Florida 34789.

ARTICLE III - DURATION

The period of duration for ROCK BOTTOM ENTERPRISES, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of the initial registered agent is PATRICK MILLER. The street address of the initial registered agent is 33911 Shady Acres Road, Leesburg, Florida 34788.

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in ROCK BOTTOM ENTERPRISES, LLC, the remaining members may, by unanimous agreement, continue the business of ROCK BOTTOM ENTERPRISES, LLC.

ARTICLE VII - MANAGEMENT

ROCK BOTTOM ENTERPRISES, LLC is to be managed by a manager and the name and address of the individual who will serve as the manager is:

The members shall have the power to adopt, alter, amend, or repeal regulations of ROCK BOTTOM ENTERPRISES, LLC.
