Initial Registered Office and Agent

This Company shall be managed by a Board of Managers which shall be elected in accordance with the Regulations and Operating Agreement of the Company.

ARTICLE VII
Amendment

This Company reserves the right to amend or repeal any provision contained in these Articles of Organization, and any right conferred upon the Members is subject to this reservation.

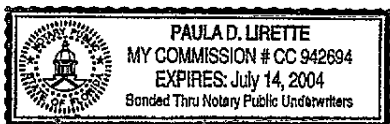


