ARTICLES OF ORGANIZATION

OF

HEALING MEDIA NETWORK LLC

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization therefor:

ARTICLE I

Name

The name of the limited liability company is HEALING MEDIA NETWORK LLC, sometimes hereinafter referred as the "Company".

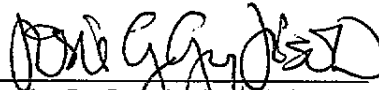
