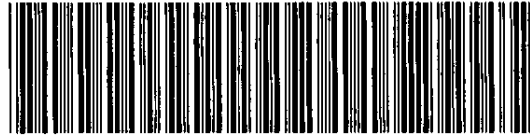

AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
THE ABA GROUP, L.L.C.,






