
ARTICLE V



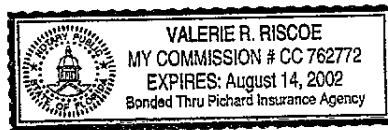


