**ARTICLES OF ORGANIZATION  
FOR

**ARTICLE 1 – Name.** The name of the limited liability company shall be MetroPlex Investments, LLC.

**ARTICLE 2 – Address of Principal Office.** The mailing address and principal office of the limited liability company shall be 5840 Red Bug Lake Road, Unit 330, Winter Springs, Florida, 32708.


**ARTICLE 3 – Registered Office and Registered Agent.** The name and the Florida street address of the initial registered agent is Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.

**ARTICLE 4 – Management.** One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company.
