**ARTICLES OF ORGANIZATION
OF
DEPAT, L.L.C.**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "*DEPAT, L.L.C.*"






