## ARTICLES OF ORGANIZATION

## WESTPOINT BUSINESS PARK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes (1995) Chapter 608, hereby make, acknowledged and file the following Articles of Organization.

## <u>ARTICLE I</u>

## <u>NAME</u>

The name of the limited liability company shall be Westpoint Business Park, LLC (the "Company"). The principal place of business and mailing address of the Company in Florida shall be 1096 East Newport Center Drive, Suite 100, Deerfield Beach, FL 33442.

## **ARTICLE II**

## **DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved in accordance with the laws of the State of Florida.

#### **ARTICLE III**

## **PURPOSES AND POWERS**

The Company is organized to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. ## **ARTICLE VI**

## **MANAGEMENT**

The Management Committee shall be appointed as provided in the Operating Agreement of the Company. Each member's vote shall be governed by the Operating Agreement of the Company.
