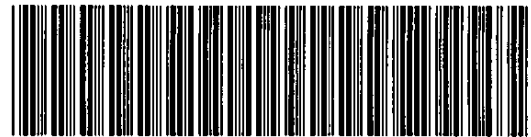


1. The date of the filing of the articles of organization was July 26, 2002.
