#### ARTICLES OF ORGANIZATION

#### The Closing Agent, Builder Services, L.L.C.

### A LIMITED LIABILITY COMPANY



- 1. Name. The name of the limited liability company is The Closing Agent, Builder Services, L.L.C..
- 2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
