

## ARTICLES OF ORGANIZATION

OF

The undersigned hereby makes, subscribes, acknowledges, and files these Articles of Organization for the purpose of forming a limited liability company under the Laws of the State of Florida.

#### ARTICLE I NAME AND ADDRESS
