ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I - NAME:

The name of the Limited Liability Company is DEL MAR CONSULTING, LLC (the "Company")

ARTICLE II - ADDRESS:

ARTICLE III - DURATION:

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually.

ARTICLE IV - PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V - REGISTERED AGENT AND OFFICE

The Company designates 200 West Palmetto Park Road, Suite 301, Boca Raton, Florida 33432 as the street address of the initial registered office of the Company and names D. Justin Niles, the Company's initial registered agent at that address to accept service of process within the state.

ARTICLE VI - MANAGEMENT

The Company shall be conducted, carried on, and managed by no less than one Manager,

who shall be elected annually by the Member(s) of the Company in the manner prescribed by and provided in the Regulations of the Company. Such Manager(s) shall also have the rights and responsibilities described in the Regulations of the Company. The name and address of the initial Manager is as follows:

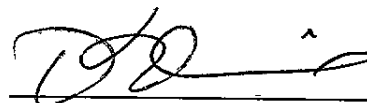

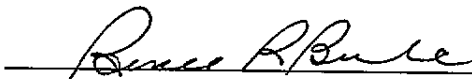

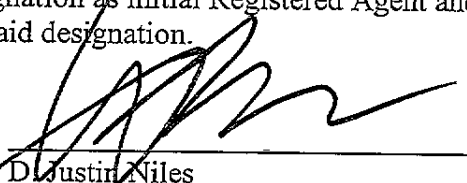
