**ARTICLES OF ORGANIZATION
OF
ENGINEERED COOLING SERVICES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Engineered Cooling Services, L.L.C. ("the company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 2402 East Scott Street, Pensacola, Florida.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is Peter W. Doyle, 2402 East Scott Street, Pensacola, Florida.

ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all the members of the company, unless specifically authorized pursuant to the operating agreement of the company. If a member transfers his or her interest in the company in violation of the terms of the operating agreement of the company, the transferee shall have no right to participate in the management of the business and affairs of the company or become a member.

ARTICLE VI - TERMINATION OF EXISTENCE

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of the remaining members, as set forth in the operating agreement.

ARTICLE VII - MANAGEMENT



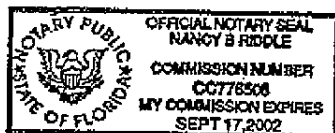


