**ARTICLES OF ORGANIZATION
OF
MH I, LIMITED LIABILITY COMPANY**

We, the undersigned natural persons of the age of nineteen (19) years or more, acting as organizers of a limited liability company under the Limited Liability Company Act of the State of Florida, hereby adopt the following Articles of Organization for the limited liability company dated this 26th day of July, 2002:

ARTICLE ONE

The name of the limited liability company is MH I Holding, Limited Liability Company.

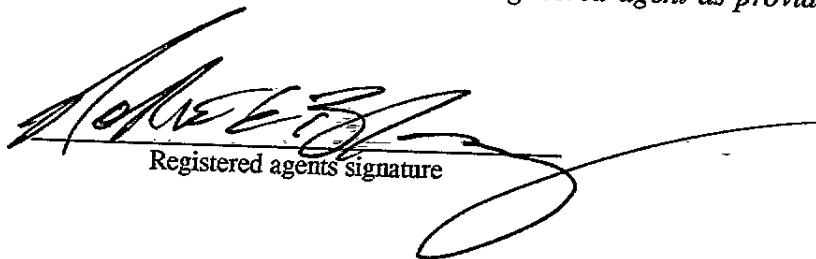
ARTICLE TWO

ARTICLE FOUR

Upon the death, retirement, resignation, expulsion, bankruptcy, dissociation of a member, an event of dissolution or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members may elect to continue the limited liability company by obtaining unanimous written consent of the remaining members desiring to continue the business under the limited liability company within 90 days of the occurrence of the terminating event.

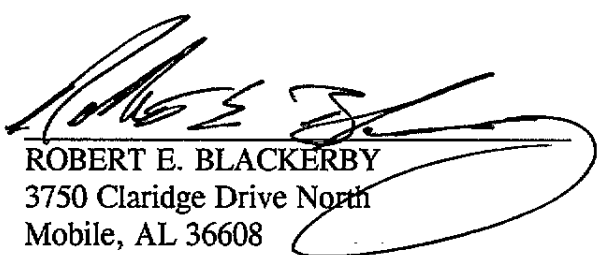
ARTICLE EIGHT
