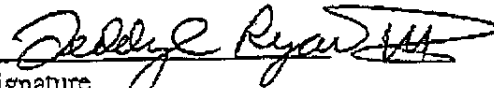

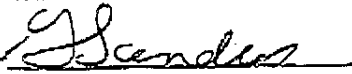
## LIMITED POWER OF ATTORNEY

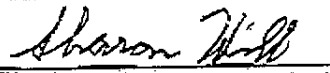
