**ARTICLES OF ORGANIZATION
OF
DST ENTERPRISES, LLC**

The undersigned, as Organizer, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the Limited Liability Company shall be DST ENTERPRISES, LLC hereinafter referred to as the "Company."

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be 1909 U.S. Highway 27 South, Clermont, Florida 34711.

ARTICLE III – DURATION

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization.

ARTICLE IV – BUSINESS PURPOSE

The primary business purpose of the Company is to engage in the provision of various services to include computer repair, web design, database development, customized system development and related services. Provided further however, the Company shall be permitted to engage in any form of legal business as permitted under the laws of the State of Florida.

ARTICLE V -- REGISTERED OFFICE AND AGENT

The name and street address of the Registered Agent of the Company in the State of Florida is Stephanie L. Camp, 1909 U.S. Highway 27 South, Clermont, Florida 34711.

ARTICLE VIII – ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the written consent of a majority of the membership interests of the Company and on such terms and conditions as shall be determined by the members. A member may transfer interest in the Company as set forth in the regulations of the Company, which shall provide for the consent of the other members. The transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his interest approve of the proposed transfer by unanimous written consent.

ARTICLE IX -- TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the then remaining members.

ARTICLE X -- MANAGEMENT

The Company shall be managed by Managers in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. 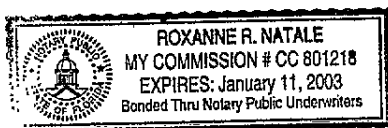
