

**ARTICLES OF ORGANIZATION
OF
San-Ann, LLC.**

The undersigned, for the purpose of forming a limited Liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be San-Ann, LLC (“company”).

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the company is 180 Central Avenue, Naples, Florida 34102.

ARTICLE III – DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date specified. The company’s existence shall terminate not later than (date), (or the company’s existence shall be perpetual) unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Peter T. Flood, 125 N. Airport Road, Suite 202, Naples, Florida 34104.

ARTICLE V – MANAGEMENT

The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company.

ARTICLE VI – ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


**CERTIFICATE OF DESIGNATION OF REGISTERED
