#### ARTICLES OF ORGANIZATION

FOR

RNB, L.C.

A Florida Limited Liability Company (FS Section 608.401) May HIS CAROLADAS

The undersigned, hereby certify that we have associated ourselves together for the purpose of forming a limited liability Company under the laws of the State of Florida pursuant to Fla. Stat. 608.401 entitled the Florida Limited Liability Company Act, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We do hereby adopt the following Articles as the Charter and authority for the conduct of business of such limited liability company.

## ARTICLE I

#### NAME

The name of the limited liability company shall be RNB, L.C., and its principal place of business shall be in the City of Royal Palm Beach, County of Falm Beach, State of Florida, but it shall have the power and authority to establish branch offices at sten prace or places as may be designated by the members.

## ARTICLE III

## **PURPOSES AND POWERS**

The nature of the business or businesses to be transacted and which this limited liability company is authorized to transact, in addition to those authorized by the laws of the State of Florida, and the powers of the limited liability company, shall be as follows:

government, or governmental authority, or of any political or administrative subdivision, or to perform and carry out, assign, cancel, or rescind any of such contracts.

- 6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others incidental or petaining to, or going our of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
- 7. The several clauses in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or

restricted by reference from the terms of any other clause. They shall be regarded as independent purposes and powers.

### ARTICLE IV

# PROFITS AND LOSSES
