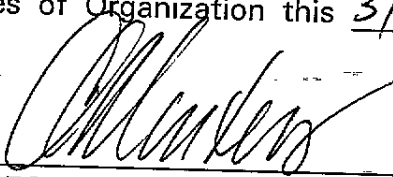
ARTICLE VI

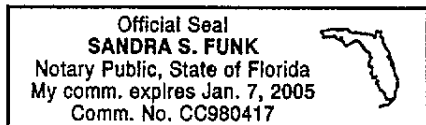
