Pursuant to Section 608.4115, Florida Statutes (2002), the undersigned, as the sole managing member of BARETOOTH PROPERTY, LLC (the "Company"), hereby certifies to the following for the purpose of correcting the Articles of Organization for the Company:

1. The name of the Company is BARETOOTH PROPERTY, LLC, a Florida limited liability company.
2. The Articles of Organization for the Company were filed with the Florida Department of State on August 2, 2002.
3. The following corrections to the Articles of Organization were adopted by the limited liability company:

ARTICLE I
Name

ARTICLE III
Purpose

ARTICLE VI
Management of Business

The Company is to be managed by a manager or managers. Marjorie Ann Adamson, 6715 Coyote Ridge Court, University Park, Florida 34201, will serve as the initial manager of the Company until the first annual meeting of the Members or until its successor is elected and qualified. The managers of the Company will be elected annually by the Members. The Members may increase and decrease the number of managers from time to time; provided, however, there shall never be more than three (3) managers or less than one (1) manager. The managers shall be Members or Affiliates of Members. There shall never be more than eight (8) Members or less than (2) Members unless amended by a majority of the Members.

4. These Articles of Corrections shall become effective upon filing with the Florida Department of State.
