The name of the Limited Liability Company is Schecky Pictures, LLC.

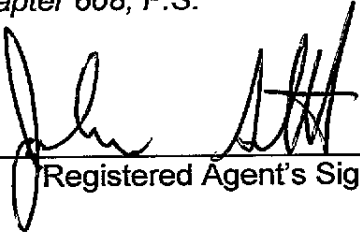

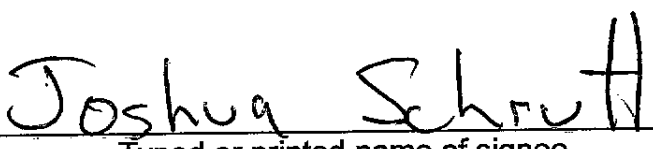

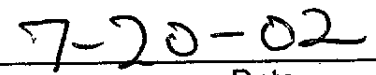
