

**ARTICLES OF ORGANIZATION
OF
STREAM GRAPHICS, L.C.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, hereby adopt the following Articles of Organization for such Company:

ARTICLE I

NAME

The name of the Company is **Stream Graphics, L.C.**

ARTICLE II

ADDRESS

The mailing address and the street address of the principal office of the Company is 708 Roberts Av, Deland, FL 32724.

ARTICLE III

INITIAL REGISTERED AGENT

The name of the initial Registered Agent of the Company is Francisco Neri at 708 Roberts Av, Deland, FL 32724.

ARTICLE IV

MANAGEMENT

The Company will be managed by one (1) member in accordance with the Company's Operating Agreement. The names and business addresses of the managing member who shall serve until the first annual meeting of members or until his successors are elected and qualified is:

ARTICLE V

RIGHT OF REMAINING MEMBERS TO CONTINUE BUSINESS

In the event of the death, retirement, resignation, expulsion, or bankruptcy of a Member or the occurrence of any other event which terminates the continued membership of

a Member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless the remaining Members, if any, of the Company whose relative capital accounts, in the aggregate, exceed fifty percent (50%) of the total capital accounts of all Members elect to continue the business of the Company within one hundred twenty (120) days after the occurrence of any of these events.

ARTICLE VI

MEMBERSHIP UNITS

The Company is authorized to issue Five Hundred (500) Membership Units.

ARTICLE VII

REGULATIONS

The regulation and management of the affairs of the Company shall be governed by the Operating Agreement of the Company. The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.

ARTICLE VIII

AMENDMENTS

The power to amend these Articles of Organization is reserved in the Members of the Company.

In accordance with Section 608.408(3), Florida Statutes, the execution of this affidavit constitutes an affirmation under the penalties of perjury that the facts stated herein are true.


