ARTICLES OF ORGANIZATION

of

“CALIBER COMMUNICATIONS, L.L.C.”

The undersigned, desiring to form a Limited Liability Company pursuant to the Florida Limited Liability Company Act (“Act”), does hereby certify as follows:

- I. **NAME.** The name of the limited liability company formed pursuant hereto shall be at all times **CALIBER COMMUNICATIONS, L.L.C.** (“Company”).



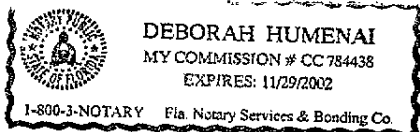


