CONTINUATION OF BUSINESS**

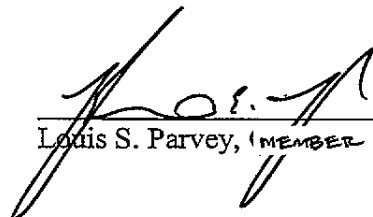
