ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of the Company, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I: NAME

The name of the limited liability company is WHITE OAK, LLC, (the "Company").

ARTICLE II: ADDRESS

The Company's mailing address and street address of the principal office of the Company is $1502 \text{ NW } 6^{\text{th}}$ Street, Gainesville, FL 32601.

ARTICLE III: DURATION
