ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of the Company, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I: NAME

The name of the limited liability company is **WHITE OAK, LLC**, (the "Company").

ARTICLE II: ADDRESS

ARTICLE III: DURATION

ARTICLE VI: ADDITIONAL MEMBERS

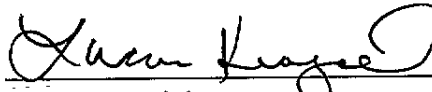
Additional Members may be admitted upon the approval of all of the Members of the Company.

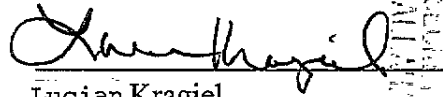
ARTICLE VIII: MANAGEMENT
