The Company shall commence its existence on the date of subscription of these articles of organization. The Company's existence shall be perpetual.

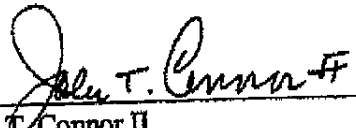
ARTICLE IV - REGISTERED OFFICE AND AGENT

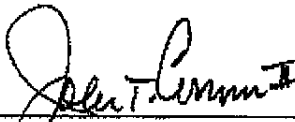
