FIRST: The name of the Limited Liability Company is: Owen Allen, LLC.

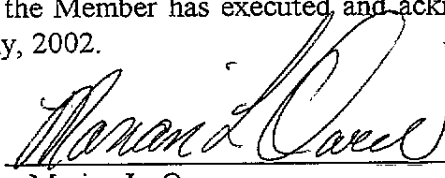

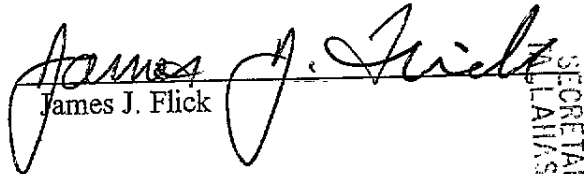
