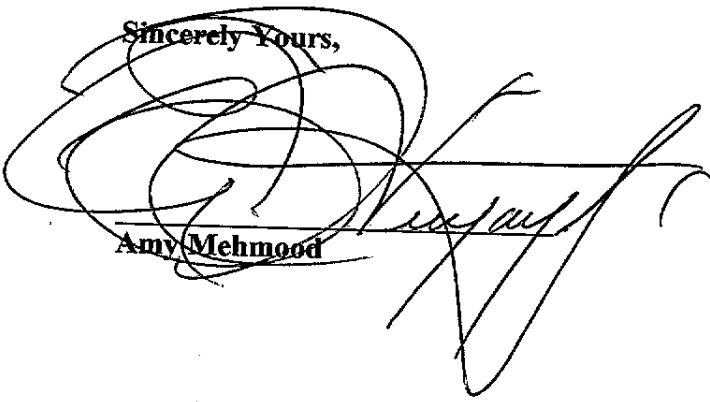

**ARTICLES OF ORGANIZATION  
OF  
XIRNET, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the Limited Liability Company shall be XIRNET, LLC

**ARTICLE II  
ADDRESS**

**ARTICLE IV  
DURATION**

The period of duration for the Limited Liability Company shall commence on the date these Articles of Organization are filed by the Secretary of State and shall continue perpetually unless terminated: (1) in accordance with the regulations of the Limited Liability Company, (2) by the unanimous written agreement of all Members, (3) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (4) upon the occurrence of any other event which terminates the continued membership of a Member. However upon any such termination event the existence and business of the Limited Liability Company may be continued with the consent of the majority of the remaining Members of the Limited Liability Company or by the amendment of these Articles or Organization providing for the continued existence of the Company.

**ARTICLE V  
MANAGEMENT AND INITIAL MEMBERS**
