

The undersigned, being authorized to execute and file these Articles, hereby certify that:

**ARTICLE I  
NAME OF COMPANY**

The name of the Limited Liability Company is CLINICAL PET OF CITRUS, L.L.C.

**ARTICLE II  
PRINCIPAL OFFICE**

TRANSFERABILITY OF MEMBERSHIP INTERESTS**

No members shall have the right to assign their membership interests in the Company without the written agreement of all of the membership interests, unless otherwise provided in the Company's Operating Agreement. If the assignment is not approved by all of the membership interests, the assignee shall have no right to become a member, to participate in the management of the Company, or to exercise any other rights or powers of a member. The Company shall have perpetual duration beginning on the date these Articles of Organization are filed by the Florida Department of State, or until dissolved in a manner provided by law or as provided in the regulations adopted by the members.

**ARTICLE VIII  
OPERATING AGREEMENT**

Any Operating Agreement (as defined in Section 608.402(24) of the Act), relating to this Company must be in writing and signed by all of the Members.
