ARTICLES OF ORGANIZATION FOR AARON HOLDINGS, L.L.C.

ARTICLE 1 - NAME

The name of the Limited Liability Company is AARON HOLDINGS, L.L.C

ARTICLE II - ADDRESS

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The members of the Limited Liability Company shall be permitted to admit additional members upon approval of members owning all the issued and outstanding Member Units of the Limited Liability Company.
