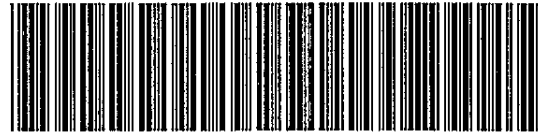



TO
ARTICLES OF ORGANIZATION
OF
RAMOGI LLC
(A Florida Limited Liability Company)


FIRST: The date of the filing of Articles of Organization was August 8, 2002.

SECOND: The following amendments to the Articles of Organization were adopted by the Limited Liability Company::
