**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be **CLAY PIT PARTNERS, #1, LLC.**

**ARTICLE II  
DURATION**



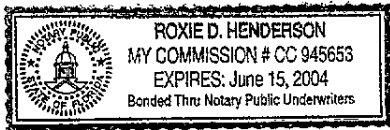



## REGISTERED AGENT ACCEPTANCE



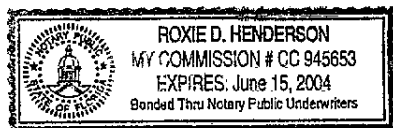
