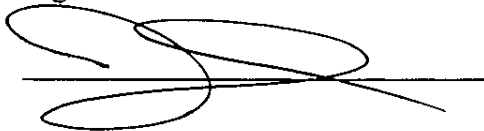
**ARTICLES OF REVOCATION OF DISSOLUTION
