ARTICLES OF ORGANIZATION
OF

CSRF, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be CSRF, LLC ("Company"). The principal office of the Company shall be 7641 Eaglet Court, Fort Myers, Florida 33912.

ARTICLE II



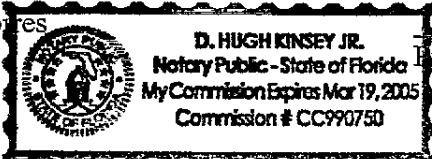

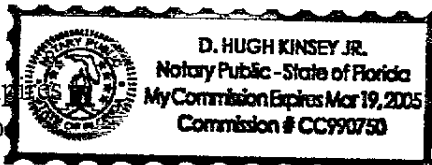
