ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is

ARTICLE VIII. ADMISSION OF NEW MEMBERS

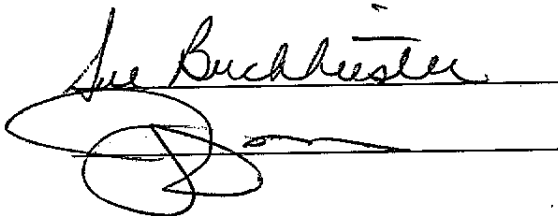
