The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

# ARTICLE 1 - NAME

The name of the limited liability Company shall be GRACEFUL HANDS WOODWORKING, L.L.C. ("Company"). The principal office of the Company in Florida shall be 5721 Southwest 95<sup>th</sup> Street, Gainesville, Florida, 32608.

# ARTICLE II - DURATION

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

### ARTICLE IX - MANAGEMENT

The Company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
