ARTICLES OF ORGANIZATION FOR NAPLES BUILDING & DESIGN, LLC

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

ARTICLE I NAME

The name of this Limited Liability Company is NAPLES BUILDING & DESIGN, LLC.

ARTICLE II DURATION/CONTINUATION
