ARTICLES OF ORGANIZATION OF BONITA GLADE, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - Name

The name of the limited liability company shall be BONITA GLADE, L.C. ("Company") The principal place of business and the mailing address of the Company in Florida shall be 6924 Willow Lane, Miami Lakes, FL 33014.

ARTICLE II - Duration

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate 30 years from the date of these Articles unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE III - Purposes & Powers

The general purpose for which the Company is organized is to acquire and dispose of real estate and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE IV - Registered Office & Agent

The name and street address of the registered agent of the Company in the State of Florida is Roy F. Custer, Jr., 6924 Willow Lane, Miami Lakes, FL 33014.

ARTICLE V - Operating Agreement

These Articles shall be deemed the operating agreement of the Company until the members may otherwise provide not inconsistent with applicable law and these Articles.

ARTICLE VI - Additional Capital Contributions

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

ARTICLE VII - Admission of New Members

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member

unless all the other members of the Company other than the member proposing to dispose of his . or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII - Termination of Existence

The Company shall be dissolved upon the death, retirement, resignation, explasion bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of the members holding a majority of the then existing contributed capital of the Company.

ARTICLE IX – Management


