ARTICLE V

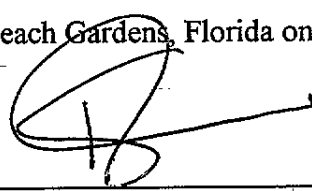
Management by Members

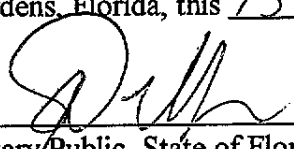

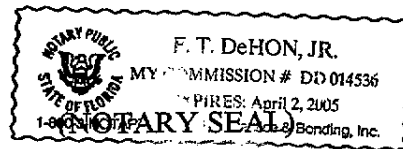

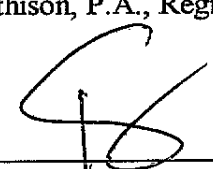
