ARTICLE I. NAME

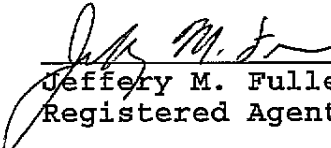
CERTIFICATE DESIGNATING REGISTERED AGENT
