ARTICLES OF ORGANIZATION OF

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said limited liability company shall be, Lucky Homes Group, LLC, and the mailing address and the street address of the principal office of the limited liability company shall 13728 SW 149 Cir Ln Apt#1, Miami, Florida 33186-5777.

SECOND: Lucky Homes Group, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.


FIFTH: The limited liability company shall be manager-managed and will have one (1) Member:
