ARTICLES OF ORGANIZATION
OF
ABOVE ALL CRANE SERVICE, LLC.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **ABOVE ALL CRANE SERVICE, LLC** ("company").

ARTICLE II - ADDRESS

The mailing address of the principal office of the company is P. O. Box 490090, Leesburg, FL 34749 and the street address of the principal office of the company is 2320 W. Montclair Rd., Leesburg, FL 34748.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV – REGISTERED AGENT AND OFFICE

The name of Company's initial registered agent in Florida is Elijah Bailey. The address of Company's registered office in Florida is 2320 W. Montclair Rd., Leesburg, FL 34748.

ARTICLE V – ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.


ARTICLE VI – MEMBERS' RIGHT TO CONTINUE BUSINESS

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only as provided for in the Operating Agreement adopted by the Company.


ARTICLE VII – MANAGEMENT


