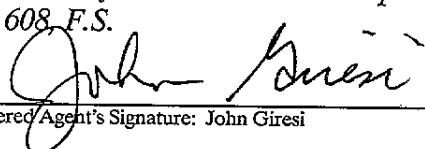

**Admission of Additional Members:**

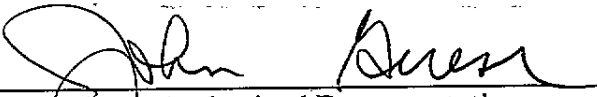

**Members' Rights to Continue Business**

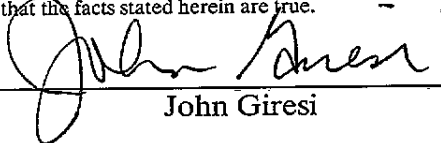
