The undersigned (the "Members") being all of the Members of SOURCE 1, LLC, hereby execute and adopt the following Amended and Restated Articles of Organization pursuant to Section 608.411, Fla. Stat. under the Florida Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety those previously adopted Articles of Organization of Company filed with the Florida Secretary of State on August 21, 2002:

**ARTICLE I
NAME**

The name of the limited liability company is SOURCE 1, LLC.
