ARTICLE I

NAME

The name of this limited liability company is "DOYLE E. CARLTON, JR. LLC", referred to in these Articles of Organization as the "Company."

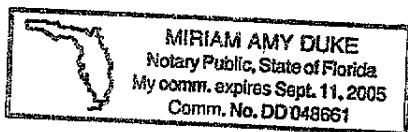


