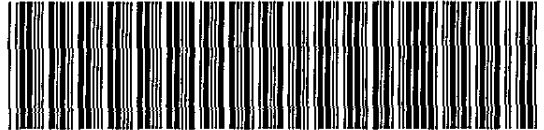

AMENDMENT TO  
ARTICLES OF ORGANIZATION  
OF  
TURNER LAND DEVELOPMENT, LLC

The undersigned as the Manager of Turner Land Development, LLC, a Florida limited liability company, hereby amends the Articles of Organization of this company as follows:

The original Articles of Turner Land Development, LLC which were filed with the Secretary of State on August 20, 2002, are being amended to reflect the name change of the limited liability company and to change the Article regarding management.

As such, Article I of the Articles of Organization is hereby amended to change the name of the limited liability company to the following:

TURNER HERITAGE HOMES OF DESTIN, LLC

In addition, Article IV Management of the Articles of Organization, is hereby deleted in its entirety and a new Article IV will be inserted as follows:

Article IV  
MANAGEMENT

The business and affairs of this limited liability company shall be managed by one or more managers, who shall be elected by the members. Frederick E. Turner, 508-A, Capital Circle, S.E., Tallahassee, Florida 32301, shall be the general manager and shall have all rights, powers and authority of a manager under Section 608.422, Florida Statutes, unless and until he resigns, or a successor is elected. In addition, the members may elect assistant managers who shall have the limited authority

to execute documents of conveyance, closing statements and other such documents necessary for the conveyance of real property, subject to the approval of the members. Such assistant manager shall have no other powers unless approved in writing by the members.

The Amendment was adopted on January 7, 2003, at a Special Meeting of the Members who directed that the Amendment take effect on the date of filing these Articles of Amendment. The number of votes cast for this amendment by the Members were sufficient for approval.
