

AMENDMENT TO

ARTICLES OF ORGANIZATION

AND CALLED STATE OF THE STATE O

The undersigned as the Manager and all the Members of **Wakulla Builders**, **LLC**, a Florida Limited Liability Company, hereby amend the Articles of Organization of this Company as follows:

The original Articles of **Wakulla Builders, LLC** which were filed with the Secretary of State on August 20, 2002, are hereby amended to change the Article regarding Management. Article IV Management of the Articles of Organization, is hereby deleted in its entirety and a new Article IV will be inserted as follows:

Article IV MANAGEMENT

The business and affairs of this limited liability company shall be managed by one or more managers, who shall be elected by the members. Frederick E. Turner, 508-A Capital Circle, S.E., Tallahassee, Florida 32301, shall be the initial General Manager and shall have all rights, powers and authority of a manager under Section 608.422, Florida Statutes, unless and until he resigns, or a successor is elected. In addition, the General Manager may elect to utilize assistant manager for limited purposes as set forth in the Operating Agreement or as approved in writing by the General Manager.

The Amendment was adopted on September 30, 2002, at a Special Meeting of the Members who directed that the Amendment take effect on the date of filing these Articles of Amendment. The number of votes cast for this amendment by the Members were sufficient for approval.
