**ARTICLES OF ORGANIZATION  
OF  
PRODESA INTERNATIONAL SOUTH, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I  
NAME**

The name of this limited liability company is PRODESA INTERNATIONAL SOUTH, LLC (the "Company").
