ARTICLE I - Name

The name of the limited liability company is **B & P VENTURES, LLC**

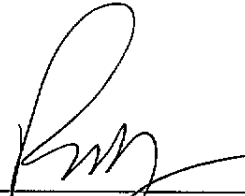
ARTICLE V - Admission of Additional Members

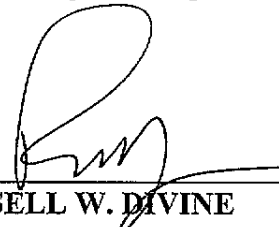
